**NOTICE: INVITING TENDER FOR INFLIGHT CATERING SERVICE**

1. Sealed tenders are invited from reputed companies/ firms for providing inflight catering service during Indian Air Force aircraft operation in Halim Perdanakusuma International Airport, Jakarta in early Jul/ Aug 2024. The following will be required: -

- (a) Asian Veg Meal (Indian) price per plate
- (b) Asian Non-Veg (chicken only) Meal (Indian) price per plate

• **Note:** In total meal will be required for approx. 200 pax. Firm preference of veg or non-veg meal will be informed later.

2. The bidding companies/ firms should have a PT/CV registration and VAT registration in Indonesia.

3. The bidding companies' firms should submit documentary proof of providing inflight catering services to foreign military aircraft/ international flight.

4. **Validity of Bids.** Bids shall remain valid and open for acceptance for a period of 90 days from the last date of submission of Bids.

5. **Earnest Money Deposit (EMD).** EMD of 3% of estimated value of the contract in the form of Bankers Draft/ Bank Guarantee having validity of six months drawn in favour of the Embassy of India, Jakarta has to be submitted along with tender bids. Bids not supported by EMD will not be considered. EMD is liable to be forfeited if the tenderer withdraws, impairs or derogates from this tender within the period of validity of this tender. EMD of unsuccessful bidder shall be returned soon after the completion of tendering process. No interest is payable on EMD.

6. **Performance Guarantee/ Security.** At the time of award of contract, the companies shall be required to submit performance guarantee in the form of banker's cheque, bank draft or bank guarantee equal to 5% of the value of the contract. The performance Guarantee shall remain valid for a period of one year beyond the date of completion of all contractual obligations.
7. No advance or down payment will be made for the required meals.
8. Bills would be settled in full through bank transfer on submission of all documents such as invoices, delivery receipts and user acceptance certificates after departure of the aircraft.
